### Evaluation Methods Used:

A combination of automated and manual testing techniques was employed for the accessibility assessment.

- Manual assessment was performed using Chrome Version 122.0.6261.129 on Windows 10, EDGE on Windows 10 and included exclusive use of the keyboard.
- Automated tools used included ANDI and WAVE web browser extension.
- Assistive technologies employed included NVDA Version 2023.3.1.
